The Draft EIR was posted on April 16, 2020. Alternative 8 was discussed in the Alternatives Section of the DEIR. I've provided a direct link for you here: <https://planning.lacity.org/eir/HollywoodCenter/deir/Draft%20EIR%20Sections/V.%20Alternatives.pdf>.

Alternative 8 was also included on the Notice of Public Hearing, sent out on July 31, 2020; as well as the reminder email re: the Public Hearing, sent out on August 21, 2020, containing the meeting agenda with a link to the VTT Staff Report, which included a discussion of why Alternative 8 was being considered. My records indicate that you were both recipients of these emails.
