Dear Mindy:

You released the Final EIR for Millennium's project a few days ago. In it you state:

"Comments received in response to the NOP and Scoping Meeting were taken into consideration in the preparation of the Draft EIR. A total of 204 written comment letters and emails responding to the NOP by public agencies and interested parties were submitted to the City. In addition, an estimated 68 individuals attended the public scoping meeting. A copy of public comments received during the NOP circulation period was provided in Appendix A-4, NOP and Scoping Meeting Comments Received, of the Draft EIR."

There are many comments you did not include in the record. Please include them. Thank you.

Furthermore, you state:

"The Department of City Planning received comment letters from approximately 332 commenters which were responded to in this Final EIR. The comment letters have been categorized in Chapter 2 in this Final EIR in the following manner: five (5) letters from public agencies, 45 letters from organizations, 73 letters of general support (Form 1), five (5) letters of general support from organizations (Form 2), 16 letters of general opposition (Form 3), and 188 letters from individuals. These letters, which were provided through written correspondence and emails are presented and addressed in Chapter 2

You have classified letters into categories calling them:

- Letters from Public Agencies;
- Letters from Organizations;
- Letters of General Support;
- Letters of General Support from Organizations;
- 16 Letters of Opposition;
- 188 Letters From Individuals;

No category for "Letters of Opposition from Organizations"?
188 Letters from individuals NOT included in letters of Opposition?

You have spent time categorizing these letters, but you left "188 letters from individuals" out of classification, most likely due to the evidence they provide as overwhelming opposition.

PLEASE INCLUDE THIS LETTER IN THE ADMINISTRATIVE RECORD TO SERVE AS EVIDENCE AND CLARIFICATION TO THE RECORD OF THE MAJOR OMISSIONS AND MISSTATEMENTS MADE IN THE CITY'S FINAL EIR.

Chapter 2 contains 4,356 pages including physical attachments as well as attachments via web links with content that has not been included.

You choose NOT TO CATEGORIZE THE 204 PLUS COMMENT LETTERS MADE DURING THE SCOPE MEETING PERIOD - AGAIN, BECAUSE THEY WERE ALL IN OPPOSITION [AS SEEN HERE IN THE 608 PAGE DOCUMENT](#)
