The underscore (_), period (.), parentheses (), and dash (-) are okay. Any other characters on the keyboard I would not recommend using in file names. The server might not read the character. See the info at <https://www.mtu.edu/umc/services/digital/writing/characters-avoid> for a little more guidance.
