Hello,

I received confirmation from our IT staff (all correspondence from which has been and will continue to be uploaded into the Administrative Record) that the files were posted as of Tuesday, September 29 at 7:57 a.m., with one additional file posted on Wednesday, September 30 at 6:59 a.m. This additional file attached documents that could not be accessed via a link provided within the email correspondence from Noah McCoy (both emails are in the record). I provided you with the links to all of the appeal documents following the upload of the additional file. From what I can tell, the one file is the only difference between your screenshot and what is currently on the site.

I do not see how providing the links you asked for implies anything other than the fact that the City is being responsive to your request. Further, the City has not been omitting documents from the record, and continues to be in compliance with the requirements of Public Resources Code (PRC) Section 21186 by making the appeal materials available within 5 business days of receipt.
