Dear Members of the City Planning Commission:

I am writing on behalf of Kilter Films at 1723 Ivar Avenue. We welcome the development and new neighbors to the area, but we are concerned that the current plan routes every piece of vehicular traffic for the West Site onto Ivar Ave. instead of adding additional driveway access points onto Yucca or Vine.

The one-block segment of Ivar Avenue between Hollywood Boulevard and Yucca Street (where our offices are located) is already snarled with traffic much of the day and this Project will undoubtedly add thousands of additional "driveway trips" to this one-block segment.

Echoing traffic concerns raised by the Pantages as expressed in their comments to the Draft EIR, we believe that this Project's significant traffic impacts on the already overburdened streets of Argyle and Ivar Avenues would be mitigated by providing additional driveway access to the Project's parking structures on either Yucca Street or Vine Street. We urge these alternatives to be explored.

Thank you for taking our concerns into consideration.
