Council District 13 is in receipt of your request for public records dated September 30, 2020 pursuant to the California Public Records Act (CPRA) regarding the Hollywood Center project.

Be advised that this office finds that "unusual circumstances" exist with respect to the request, as that term is defined in California Government Code section 6253(c). Unusual circumstances exist because of (1) the possible

need to search for and collect the records from field facilities or other establishments that are separate from this office, and (2) the possible need to search for, collect, and appropriately examine a voluminous amount of separate and distinct records in order to respond to the request, and (3) the possible need for consultation with another agency having a substantial interest in the determination of the request. (See Government Code sections 6253 (c)(1), (c)(2), and (c)(3).)
