Thank you for your email. To clarify, in my email dated September 17, 2020, I had stated that we were currently in the process of *collecting* internal emails from City staff those who may have correspondence regarding the Project, and invited you to check back with me in a week or two to see when those will be posted.

A request was submitted last week to IT to get them uploaded by the end of this week, and will include Craig Bullock's emails. I know that the emails from Daniel Schneidereit are also of interest to you; however, LADBS submitted an extension until November 16, 2020 to provide us with the requested documents. As such, please be advised that Daniel's folder will not contain any updated correspondence.
