Hello,

Thank you for bringing this to our attention. This correspondence does appear to be missing the attachment, and I have put in a request to get that corrected.

I would like to clarify, however, that I do not move or remove attachments. In the instances where you have brought your concerns to our attention, I have been transparent when an error has occurred, and let you know as soon as the error has been corrected. In the instances where you were looking for something but could not find it, or thought something was missing but the link was in a different location on our website, I have pointed you to the correct location.

As previously explained, and aside from the email you just brought to our attention, attachments have been included as part of the *original email* with which they were sent, unless the sender has requested otherwise. If the original email is a general inquiry, the original email, as well as my response, would be filed under Email Correspondence. If the original email provides comments on the Project, the original email would be filed under Public Comments, and my response would be filed under Email Correspondence. In no instance would an attachment from a sender be included in my response to the sender, unless I reattached it in my response.

If you have links to original emails from a sender where you believe attachments have been removed, I would be happy to investigate further. Otherwise, I will let you know when the attachment to David Carrera's email has been updated.
