Dear Ms. Gray:

We are in receipt of your below October 19, 2020 email in response to our October 9, 2020 CPRA request to the Mayor's office.

The date of February 4, 2021 [your letter said 2020] to produce responsive documents to our request is too late and far exceeds the requirements to timely respond under Government Code § 6253 - "No notice shall specify a date that would result in an extension for more than 14 days."

Given the speed with which the City has continually accommodated the developer in the Hollywood Center matter at the expense of the public's rights, equal if not more speed is owed by your office in properly responding and producing documents regarding our CPRA requests.

We reiterate our request that the Hollywood Center Environmental Impact Report ("EIR") process not be completed until after the City has produced all of the documents requested, and we have had reasonable time to review them to make better and more complete objections as part of the record, and for consideration by the decision makers.

Please provide a reasonable date for production of the documents we requested. During a year when two Councilmembers have been charged by the DOJ and the City Attorney's office has been fined for obstructions in evidence production, one would hope the Mayor's office would lead with a better example.

Please confirm. Thank you.
