While some of the 12/10/2020 document requests (see attached) would fall within the ambit of some of our prior requests, that is not necessarily correct for all of them, as some of them relate to very current events. For example, see Nos. 2, 5, 7, 8. We would ask that you or the City Attorney review each discreet request and

not assume they are already encompassed within our prior requests. Also, if any of the responsive documents can be provided sooner than late January, or on a rolling basis, please do so.

My client and thousands in the community are deeply concerned about this proposed project, and anxious to have this information. In the past, you have been fairly prompt and responsive in answering community requests for information about project status.
