Dear Ms. Nguyen:

Please include this communication in the Administrative Record for this matter.

The letters that have been submitted under or with cover emails of this office clearly state "The Silverstein Law Firm" in the letterheads. It is confusing and improper that you would label them in the running Administrative Record with my assistant Veronica's individual name instead of this firm's name or my name as author of the letter. The emails are cover emails for the actual submitted letter.

If the City insists on mislabeling documents based on a cover email, then you should at least label the cover email and the separate letter or document, respectively, with the names of their senders. Even OPR made a distinction between a cover email and the letter attached to it by using the name on the letterhead when labeling comments for the ELDP application for this project. Veronica of our office was the one that sent the letters via email, but they accurately labeled them "Silverstein Law Firm" in the list of comment letters. Are we to understand that the LA City Planning Department is not capable of accurately and correctly labeling documents like a state agency does?

We ask that you correctly label the letters listed in the running Administrative Record for this matter. This includes the letters we have submitted and those submitted by any other community group or agency whose names you have hidden by only including the sender's name, e.g. "A. Iles" instead of Hollywood Dell Civic Association, or "G. Skarpalous" instead of Hollywood United Neighborhood Council.

Please advise when you have corrected this disregard for transparency to the public and keeping an accurate record.
