The Hollywood Hills West Neighborhood Council (HHWNC) is one of the certified neighborhood councils in the City of Los Angeles. The Hollywood Center Project's 4.46 acre site in Hollywood is just to the East of HHWNC's area.

At a meeting of HHWNC's Board on May 20, 2020, HHWNC's Board voted (20 to 0 with 1 recusal) to recommend and request that the City of Los Angeles' elected officials and the City's Planning Director extend the public comment deadline on the Hollywood Center Project's DEIR for at least 75 days beyond the current June 1, 2020 deadline. The public comment deadline should not be set any earlier than August 15, 2020.
