This letter is to inform you that the Los Angeles Department of City Planning is reviewing the following proposed project:

The Project would involve a mixed-use development comprised of 260 multi-family residential dwelling units and approximately 17,800 square feet of community-serving retail and restaurant uses located within the Hollywood Community Plan area of the City of Los Angeles. As part of the Project, the existing two-story, 9,000-square-foot Attie Building located at the corner of Hollywood Boulevard and Wilcox Avenue would be retained and integrated with new development. New development would range in height from one to 15 stories with a maximum height of 160 feet. Upon completion, the Project would include approximately 278,892 square feet of floor area, and approximately 420 parking spaces in two subterranean and three on and above grade levels. The Project would also include 33,750 square feet of open space provided within landscaped courtyards and terraces, a sky deck, and a pool deck.

Per AB 52, you have the right to consult on a proposed public or private project prior to the release of a negative declaration, mitigated negative declaration or environmental impact report.
