

Dear Ms. Webber:

As you are aware, 6436 Hollywood Blvd LLC and 1624 Wilcox LP (collectively, the "<u>Applicant</u>") is applying to the California Governor to request certification of the Hollywood and Wilcox project (the "<u>Project</u>") as a Leadership Project subjected to streamlined environmental review pursuant to the Jobs and Economic Improvement through Environment Leadership Act of 2011 (the "<u>Act</u>"), California Public Resources Code § 21178 *et seq.* as amended by SB 763 and AB 734.
