The Department of City Planning is preparing to release a Draft Environmental Impact Report (EIR) for this Project, which has been designated by the State as an Environmental Leadership Development Project (ELDP). As part of this process, the City is required to collect and upload a record of proceedings for the Project at the time the Draft EIR is published, and continuously thereafter in concurrence with the administrative process.
