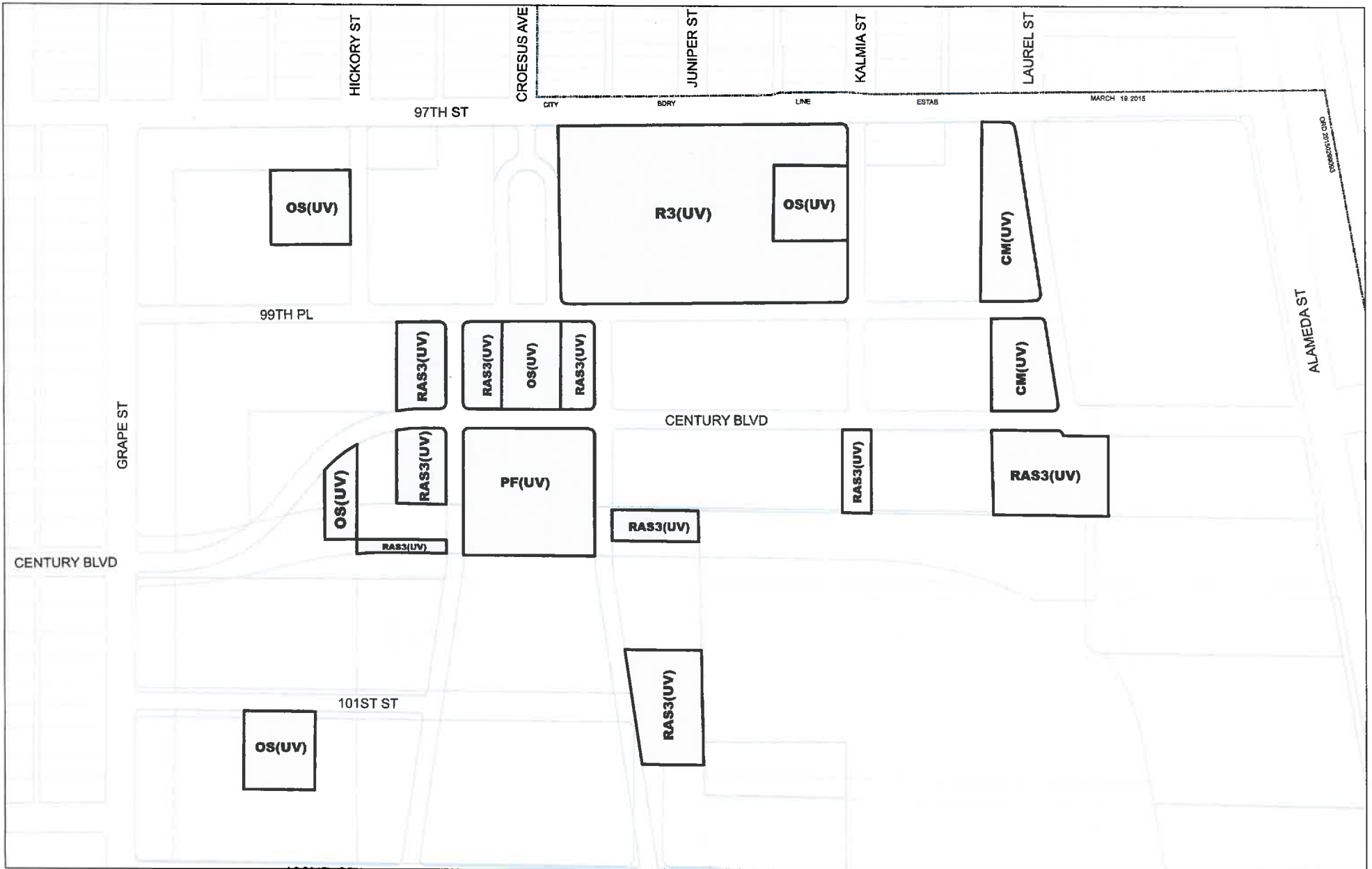


ORDINANCE NO. 184346

DECLARATION OF POSTING ORDINANCE
