Via De La Paz Peninsula

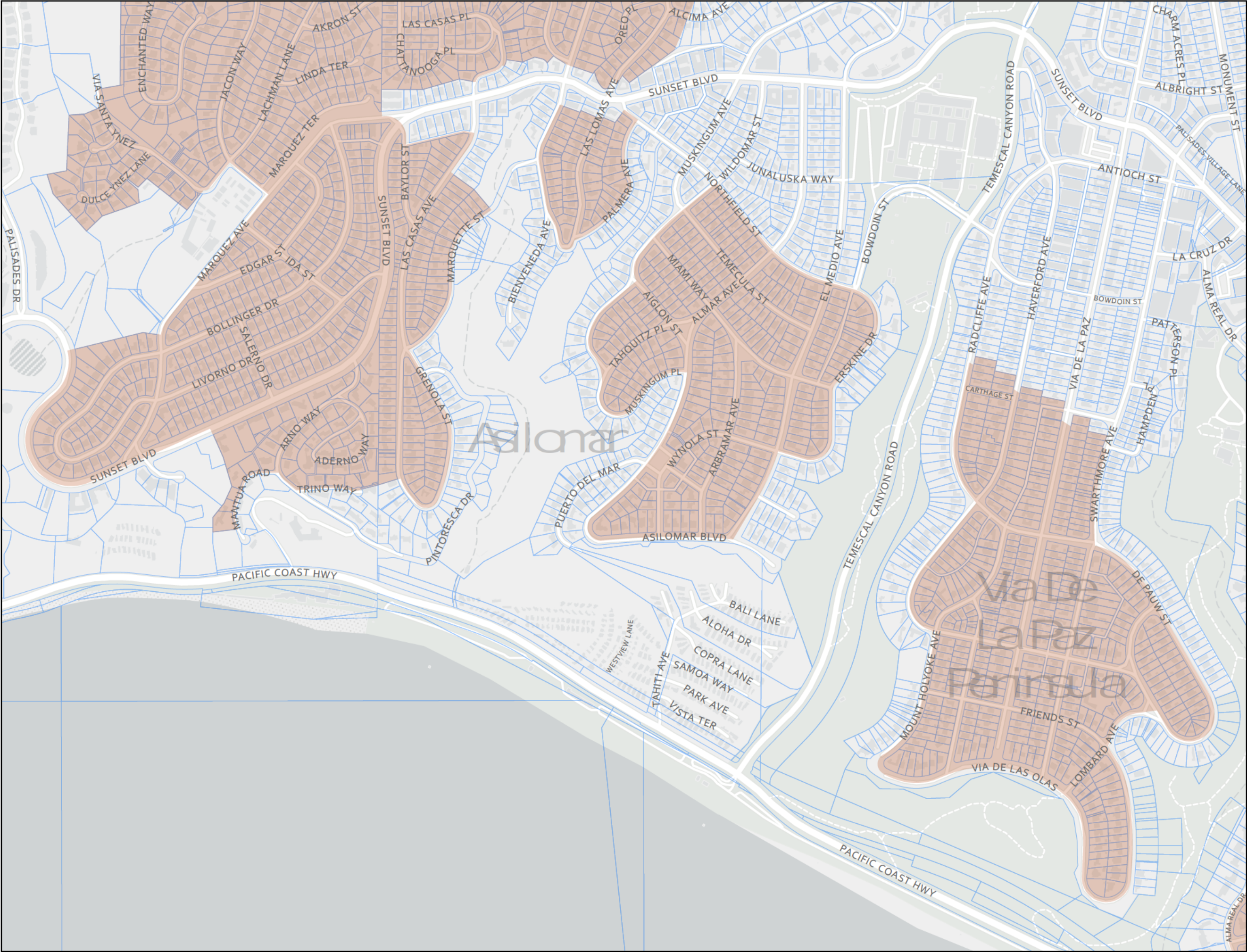
