SUBJECT: **HOME-SHARING PROGRAM - ANNUAL INFLATION ADJUSTMENT
UPDATED FINES FOR VIOLATIONS TO TAKE EFFECT ON SEPTEMBER 1,
2025**

The Los Angeles City Council adopted the City's Home-Sharing Program (Ordinance No. 185,931 under CF 14-1635) in December 2018, with an effective date of July 1, 2019. The Home-Sharing Program created a regulatory framework to restrict Short-Term Rentals to a Host's primary residence in an effort to prevent the wholesale conversion of housing into Short-Term Rentals. All Short-Term Rentals in the City of Los Angeles must be properly registered for Home-Sharing with the City. This registration requirement does not apply to City-recognized hotels, motels, bed and breakfasts, or Transient Occupancy Residential Structures, which are exempt from the Home-Sharing regulations.

Hosting Platforms, Owners of Primary Residences, and/or Hosts and/or Persons advertising a Rental Unit may be issued a citation with a fine amount pursuant to Los Angeles Municipal Code (LAMC) Section 12.22.A.32.(g)(4) if the subject Rental Unit is found to be in violation of the program's provisions. LAMC Section 12.22.A.32.(g)(4)(iii) allows for the fine amounts to be updated annually, from the effective date of the ordinance, according to the Consumer Price Index for All Urban Consumers ("CPI-U"). The update will be based on the Bureau of Labor Statistics CPI-U for the Los Angeles area (Los Angeles-Long Beach-Anaheim).

The calculated inflation adjustment is **3.2%**, based on the CPI-U average for the 12-month period ending on June 30, 2025. The adjusted fine amount is reflected in the following table:
