Housing Element Rezoning Program Draft Ordinances

In June 2024, Los Angeles City Planning released revised draft ordinances for the Housing Element Rezoning Program. Information on the draft ordinances can be found here. Following a public hearing on July 25th, the City Planning Commission (CPC) is scheduled to review these draft ordinances on September 26, 2024. The meeting will be available in person, via Zoom, or by phone.

After the CPC review, the ordinances will be forwarded to the Planning and Land Use Management (PLUM) Committee and then to the full City Council for further consideration. New Zoning Code

City Planning is in the process of developing a zoning system and zoning code for the first time since 1946. The New Zoning Code aims to be more modern, efficient, user friendly, and responsive to the diverse needs and visions of our City's communities. Zoning determines the permitted uses on a parcel and provides regulations for development, including height, bulk, use, and setbacks. The adoption of the <u>Downtown Community Plan</u> will mark the initial implementation of the New Zoning Code, and will expand to other neighborhoods as the Community Plans are updated throughout the City. The New Zoning Code is currently being reviewed by the City Attorney's Office for form and legality and is anticipated to be adopted later this year, and operational in early 2025. We will also be updating our Department's website with new resources to help everyone navigate the New Zoning Code.

Environmental Justice

Los Angeles City Planning has released the <u>Outreach Summary</u> for the initial phase of the Environmental Justice (EJ) Policy Program. After engaging with over 1,800 Angelenos and gathering 2,000+ comments, and consulting with a working group of community-based organizations and a

technical advisory group of city departments, the next phase will involve drafting policies and programs. Draft documents will be shared for public comment in winter 2025.

Redevelopment Plan Procedures

Los Angeles City Planning has proposed a <u>new draft ordinance</u> to transition Redevelopment Plan Procedures to Chapter 1A. This ordinance relocates these procedures from Section 11.5.14 of Chapter 1 of the Los Angeles Municipal Code (LAMC) to a new Division 13B.12 in Chapter 1A. To maintain consistency with Chapter 1A this update includes minor updates to policies, standardized procedures, and improves clarity and readability.

The <u>draft ordinance</u> was reviewed and approved on consent at the City Planning Commission meeting on September 12, 2024. The ordinance will be heard next at a Planning and Land Use Committee meeting that is currently TBD.

South LA Development Services Center

On Tuesday, July 23, 2024, Los Angeles City Planning opened its first <u>Development Services Center (DSC)</u> in South LA in partnership with the Los Angeles Department of Building and Safety (LADBS) and the Los Angeles Housing Department (LAHD). Located on the first floor of the Mark Ridley-Thomas Constituent Service Center at 8475 Vermont Avenue, the South LA DSC is a convenient one-stop shop for local residents to access important planning services. The center offers in-person appointments on Tuesdays and Thursdays from 8.a.m. to 4 p.m., as well as virtual appointments on Mondays, Wednesdays and Fridays.

Al Fresco Deadline Extended to December 31

The deadline for the temporary Al Fresco program has been extended, and all Al Fresco Temporary Authorizations will now expire on December 31, 2024. Businesses with these Temporary Authorizations must apply for <u>permits</u> to offer permanent outdoor dining beyond the temporary program. Since the review and inspection process can be lengthy, it is strongly recommended to apply early to avoid any disruptions.

Boyle heights Community Plan update

The <u>Boyle Heights Community Plan Update</u> sets long-term goals and policies for the future of Boyle Heights, one of Los Angeles's most transit-friendly and densely populated neighborhoods. The Plan encourages growth near transit hubs and commercial areas while preserving the variety of housing densities and the neighborhood's historic character. The Plan is expected to be reconsidered by the City Council's Planning and Land Use Management Committee (PLUM Committee) at its **upcoming meeting scheduled for Tuesday, September 17, 2024.** To recap the Plan's adoption progress: In December 2023, the Los Angeles City Council (City Council) considered the Plan and approved modifications. These changes were required to be considered by the City Planning Commission (CPC), who issued its recommendation on the City Council's modifications on January 11, 2024 and the Mayor issued their recommendation on the modifications on May 30, 2024. City Planning has prepared a finalized version of the Plan, inclusive of General Plan policies, maps, implementing ordinances, and revised environmental studies, and transmitted those items to the City Council for final adoption.

The City Council must take action by September 27, 2024. To stay updated, subscribe for notifications on the City Clerk's website. The PLUM Committee meeting agenda will be posted 72 hours before the meeting, with options for public participation both in person and online. The meeting will also be streamed live online and accessible by phone.

East San Fernando Valley Transit Neighborhood Plan

The Plan will update land use and zoning regulations along Van Nuys Boulevard in Pacoima, Arleta, and Panorama City, in alignment with the new Metro light rail. The plan aims to promote equitable housing, support transit use, and boost economic vitality in these communities.

Through extensive outreach, five Guiding Principles have been developed based on community feedback, addressing key topics such as: housing equity, local business diversity, connectivity, climate resilience, and community identity.

A draft land use proposal is expected by spring 2025, with more opportunities for community engagement to follow.
