



Access to Healthy Food

- **Total Comments: 13**
- New high-quality grocery stores, including small neighborhood markets
- Access to fresh and healthy (e.g. organic) food sources that are affordable
- Additional locations for regular farmer's markets throughout the community
- Overabundance fast food and drive-through establishments

Affordable Housing

Total Comments: 16

- Additional multi-family affordable housing that supports all income levels, especially extremely- and very-low income households
- Additional affordable housing for seniors with supportive services and programming
- Stop demolition of existing affordable housing stock and instead implement improvements
- Too much construction of luxury housing that does not support community housing needs and exacerbates displacement issues

Architectural Features

Total Comments: 13

- Preference for a mix of building styles and architectural diversity old, traditional, modern, art deco
- Creative architectural approaches embellishment of façades and preservation of historic light posts
- Architecture should reflect the unique personality of the corridor
- New buildings should be designed in ways that complement the existing built environment
- Dislike boxy modern architectural style and structures that do not match the existing context

Community Facilities

- Community facilities along the Rail to River Bike/Ped Path should be accessible to all community members
- New community facilities that improve community health fitness and recreation venues, sport fields, mental health centers, hospitals, health clinics
- New community facilities that support arts and culture libraries, art centers, museums, performance venues, multi-cultural community centers with programming
- New community facilities that foster community education investment centers, youth centers, parent centers, good schools with child care
- New community facilities to support homelessness shelters, services and referral centers

Community Facilities

Total Comments: 55

- Seniors and persons with disabilities need new community facilities that provide them exclusive services and programming
- Not enough accessible community facilities that serve youth, seniors, persons with disabilities
- Community facilities are not accessible via bus and rail
- Too many new schools being developed and should instead focus on improving existing sites

Favorable Uses Total Comments: 65

- New retail and commercial uses to complement the Rail to River Bike/Ped Path neighborhood markets, coffee shops, community cafes, restaurants, food halls, entertainment venues, open floor plans
- New light manufacturing uses that support local employment, or potentially worker cooperatives
- Additional high-quality restaurant and food industry uses that support local employment
- Support existing and new small local businesses and startups that encourage community ownership
- Future uses should be of high quality and be both family- and community-oriented
- Preserve the historic character of the community and recognize its unique history
- Take advantage of existing building stock through adaptive reuse
- Stationary and regulated street vending and viable spaces for vendors
- Provide support for local vendors through public-private partnerships or incentivizing local businesses to grant space to vendors
- A public benefits system could provide a valuable increase in availability of community resources
- Additional high-quality affordable housing
- Support sustainable mixed-use development with a mix of retail, restaurants, office, and housing
- Need new high-quality hotel and hospitality uses
- Demolition of existing housing stock does not support community housing needs
- Removal of valuable open green space is harmful

Landscaping Total Comments: 14

- Abundance of landscaping and greenery in all future building development
- Landscaping should be ecologically sound and promote sustainability storm water capture, solar, renewable, drought tolerant
- Landscaping should support community needs for open and green space public seating areas, tree canopy, playgrounds
- Existing buildings lack sufficient landscaping and proper maintenance
- Impermeable pavement is not sustainable

Maintenance Total Comments: 18

- Future building development could benefit from regular good maintenance power washing, landscape upkeep, trash removal, street cleaning
- Regular sidewalk and curb repair, and removal of buckling trees to ensure public safety and accessibility
- Murals are a valuable community asset and need protection from vandalism
- Buildings are raggedy in appearance and unmaintained broken windows, deteriorating paint, graffiti
- The abandoned railroad track and surrounding streets are littered with trash and large objects cars, couches, furniture
- Sidewalks are overgrown with excessive gardens or plants that are potentially dangerous or harmful

New Uses Total Comments: 37

- Sustainable and cleaner uses that deter industrial pollution and local air quality issues green and renewable energy, zero waste industries, non-waste education centers, urban agriculture
- Uses that encourage community interaction, communication, and education art hubs and venues, arts and music education centers, coworking spaces, meditation spaces, youth mentorship centers, vocational training centers
- Emerging industry uses that foster business development and creative collaboration food incubators, entrepreneurship development centers, small and big technology hubs, small business incubators
- New retail and commercial uses that are innovative and support local culture and community needs multi-cultural markets and shopping districts, resources for seniors, breweries

Non-Favorable Uses Total Comments: 75

- More accountability for polluting industries with unfriendly environmental practices
- Cannabis industrial areas located away from schools and cause less nuisance in the community
- Auto-related uses tire shops, repair shops, car dealerships, part yards, storage yards, gas stations
- Incompatible uses that disrupt community cohesion heavy industrial uses near residential homes, industrial uses along commercial streets, recycling centers, toxic and polluting industries, illicit activity at motels
- Uses that use public right of way for unpermitted storage and encourage illegal dumping pallet yards, storage yards
- Uses that discourage public health liquor stores, alcohol sales, marijuana dispensaries, smoke and vape shops, fast food and drive through establishments
- Overconcentration of uses bail bonds, laundromats, payday lenders, pawn shops, wig shops, t-shirt shops, churches and religious institutions
- Unpermitted street vending that is unregulated and disrupts the public right of way
- Big-box and chain stores that de-emphasize local community context
- Vacant lots and buildings that are unmaintained
- Uses that will not support a healthy built and natural environment along the future Rail to River Bike/Ped Path
- Green gentrification could become an issue with environmental improvements in the community

Pedestrian Amenities Total Comments: 31

- Additional pedestrian amenities that support active transportation bike repair hubs, bike racks, benches, pet stations, trash and recycling cans, water refill stations
- Range of outdoor rest areas and social gathering spaces small courtyards, community space for large gatherings, public space around small businesses, clean and well-covered bus shelters, parklets
- Pedestrian friendly wide sidewalks, street crossings, and connections to Metro stations
- Uncovered outdoor areas and bus shelters without protection from sun and rain
- Lack of amenities benches, bike racks and lockers, lighting

Publicly Accessible Open Space

- Additional open space facilities green space, playgrounds, public seating areas, public plazas
- Parks should be large in size, but pocket parks should also be implemented to take advantage of minimally available space
- Maintenance and overall upkeep is important to keep open space clean and accessible
- Improvements to existing parks are needed
- Recreation programming for youth could ensure continued use

Publicly Accessible Open Space

Total Comments: 20

Safety for all community members must be a priority, especially at night

Rail to River Bike/Ped Path

Total Comments: 10

- Need ADA access with lighted crosswalks
- Protected and controlled access to ensure pedestrian safety, especially for youth and seniors
- Lighting and surveillance on the path is essential to ensure community safety, especially at night
- Amenities should be sustainably-oriented solar powered pavers, landscaping
- Intersection crossings could benefit from leading pedestrian intervals and scramble crossings
- North-south active transportation infrastructure is essential to ensure equitable community access
- Concern about long-term maintenance and safety of the Rail to River Bike/Ped Path
- Construction of the Rail to River Bike/Ped Path could disrupt neighboring uses and create environmental hazards

Shade Trees Total Comments: 16

- Abundance of additional trees to provide shade, beautify the community, and provide air purification
- Preference for native tree species and trees like palms that fit the existing community landscape
- Ficus trees disturb the sidewalk and cause too many maintenance issues

Site and Building Design

- Design with Rail to River Bike/Ped Path in mind that is complementary, symbiotic (organic), incorporation, cohesive
- Community-oriented public art and murals that reflect the local community and history of the Slauson Avenue corridor
- Design that supports active ground floor uses
- Public space that connect buildings to the future Rail to River Bike/Ped Path
- Consistent façade design requirements that emphasize accessibility and transparency
- Sustainable design features or LEED requirements for new development green walls, vertical gardens, community gardens, self-healing cement
- Improved and sufficient lighting around buildings and the Rail to River Bike/Ped Path
- Fencing necessary for safety and security should be attractive, permeable, and accessible
- Appropriate amount of on-site parking with structures for parking in rear to create less conflicts
- Smaller building footprints and three or five story maximum building height
- Artistic wayfinding and signage
- Inconsistent design, especially with existing rear facades of buildings along the future Rail to River Bike/Ped Path
- No defined barrier between indoor and outdoor spaces
- Large blank walls and gates of warehouses, industrial, and fortress-style buildings create disconnect to the community
- Overabundance of concrete and pavement
- Insufficient lighting in many spaces creates safety and security, nuisance and crime issues
- High-rise and buildings over three stories tall do not fit within the existing built environment
- Not enough parking overall and stand-alone parking structures could create more traffic issues
- Standard shopping centers and strip malls

Streetscape Features

Total Comments: 8

- Additional sidewalks that are wider
- Additional bus shelters, trash receptacles and other amenities that encourage active transportation
- Walkable pathways in and around the Goodyear Tract could help connect the community
- Missing sidewalks, crosswalks, and lighting along Slauson Avenue
- Active transportation infrastructure is not given the same priority as motorized traffic lanes

Strong and Sustainable Local Economy

Total Comments: 40

- Dedicated space to promote and assist local entrepreneurship training
- Access to livable above minimum wage jobs
- Business Improvements District (BID) to help improve safety along and around the future Rail to River Bike/Ped Path
- Engagement and collaboration with existing businesses and local employment base
- Local hire requirements for all community investment with enforcement
- Support for small and active business spaces that prioritize local employment
- Nature of work is changing and need to be forward thinking to support diverse industry sectors arts and production, community services, crafts, education, green, health, music design, technical, technology
- Diverse workforce needs Spanish/Latin, multicultural immigrants (monolingual), youth, retired and seniors, homeless, formerly incarcerated, veterans
- Existing low-wage employment opportunities

Other Suggestion or Concern

- Communal spaces for food trucks to gather
- Access to public restrooms and drinking fountains
- Community education on travel and mobility
- Permit parking to reserve spaces for residents and to encourage use of public transit
- More significant focus on safety and activity programming for kids, especially persons with disabilities
- Community neighborhood watch programs as alternative to policing
- Additional and increased preservation of housing rent control
- Community member coalition to ensure developers are keeping their commitments to the community
- Access to rental and shared bicycles
- Slow down cars and heavy flows of traffic along the corridor
- Lack of lighting in areas and existing lighting infrastructure is not maintained
- Crime in popular retail and commercial areas
- Buildup of homeless encampments and loitering in public areas
- Safety risks for all community members, especially youth ages 5-11
- Narrow streets designed for small cars being used by larger vehicles and trucks
- Unmaintained and unsafe streets without crosswalks that do not support pedestrian mobility
- Traffic congestion along Slauson Avenue and at major intersections
- Need north-south active transportation routes to connect Rail to River Bike/Ped Path to Downtown Los Angles
- Real estate business speculation and absentee landlords
- Food trucks are a community nuisance that results in unwanted noise and trash
- Overnight RV parking is prevalent and unregulated


