
IOBS ORIENTATION







EXPANDING THE AREAS WHERE MIXED USE IS ALLOWED

The Draft Downtown Community Plan promotes employment by expanding where mixed use is permitted through use regulations.

Under each *Policy Intent*, there is a list of the *Draft Use Districts(a)* component of the zone string) which have been applied to implement the stated intent. You can learn more about these draft zones in greater detail at the Zoning Station.





POLICY INTENT: Residential uses are prioritized in this area.

DRAFT USE DISTRICTS: Residential General 1

POLICY INTENT:

Employment opportunities are geared toward businesses such as small grocery stores and professional offices. Ground floor establishments provide needed services, with limited hours of operation. Commercial establishments are restricted to 1,500 sf. – Examples: professional offices for dentists, acupuncturists, & accountants, bodega, and home occupation.

DRAFT USE DISTRICTS:

Residential Neighborhood Amenity 1

POLICY INTENT:

Employment opportunities are oriented around entertainment & services that are needed on a daily basis. Ground floor commercial establishments are limited to 5,000 SF to prioritize small businesses, including offices, & niche commercial clusters with a regional draw. – Examples: cultural institutions, banks, salons, restaurant and retail, medical offices, and other professional offices.

DRAFT USE DISTRICTS:

Commercial-Mixed Neighborhood 1

POLICY INTENT:

Employment opportunities are in a range of job types. Commercial establishments are limited to 50,000 SF to encourage businesses that serve community within a ½ mile radius. - Examples: pet services, entertainment production, banks and financial institutions, salons, grocery stores, medical offices, restaurant and retail.

DRAFT USE DISTRICTS: Commercial-Mixed Community 1

POLICY INTENT:

Employment opportunities in this area are geared toward large scale businesses, hotels, department stores, and regional and destination services. - Examples: schools, cultural institutions, entertainment production, office headquarters, medical facilities, personal services, restaurant and retail.

DRAFT USE DISTRICTS:

Commercial-Mixed General 1

POLICY INTENT:

Employment opportunities are in hospitality businesses, service-related jobs, live entertainment venues, cultural institutions, and restaurants. Allow for a streamlined process for restaurant and entertainment uses. – Examples: hotels, live entertainment venues, retail, restaurants, cultural institutions.

DRAFT USE DISTRICTS:

Commercial-Mixed Entertainment

POLICY INTENT:

Employment opportunities are geared toward production, with flexible internal spaces where creative enterprise, manufacturing, creative office, & limited Live/Work can locate. - Examples: office, clean technologies, production, creative enterprise

DRAFT USE DISTRICTS:

 Industrial-Mixed Hybrid 1 Industrial-Mixed Hybrid 2

POLICY INTENT:

Employment opportunities are oriented around social service activities, fabrication, and production of goods for wholesale or retail distribution. - Examples: social services, social enterprise organizations, wholesale

DRAFT USE DISTRICTS:

Industrial-Mixed 1

POLICY INTENT:

Employment opportunities are geared toward industries ranging from wholesale, manufacturing, and distribution.

- Examples: storage facilities, garment fabrication, distribution

centers

DRAFT USE DISTRICTS: Industrial-Mixed 2

POLICY INTENT:

Employment opportunities in this area are geared toward industries ranging from wholesale, manufacturing, and distribution. – Examples: storage facilities, garment fabrication, distribution centers

DRAFT USE DISTRICTS:

 Industrial Restricted Industrial Heavy

POLICY INTENT:

Employment opportunities are oriented towards governmental, administration, institutional, civic, and cultural jobs for the City and County. The employment base will be further diversified by commercial services and amenities, to support daytime workers.- Examples: Public administration, restaurant and retail.
