Introduction

Street Designations are established in the General Plan Circulation Element, called the Mobility Plan 2035. The Boyle Heights Community Plan Update includes updates to the enhanced networks and street designations throughout the Boyle Heights Community Plan Area. The updated street designations and enhanced networks can be found in the following tables and attached maps.

The Mobility Plan recognizes the various modes of travel that need to be accommodated on streets (such as walking, biking, and driving). To achieve consistency with the Proposed Plan, the General Plan Amendments will include updates to enhanced networks that prioritize specific modes of travel for improvement. These updates depict multiple networks of streets prioritized for bicycle, transit, and vehicle movement, named the Neighborhood Enhanced Network, Bicycle Enhanced Network, and Transit Enhanced Network. No changes are proposed for the Vehicle Enhanced Network, Pedestrian Enhanced Network, or Goods Movement Network.

Amendments to Mobility Plan 2035 Maps

The Citywide General Plan Circulation System Maps A5 and A7 and Enhanced Network Maps of the Mobility Plan 2035 shall be amended to reclassify street designations and enhanced transit, bicycle, and neighborhood networks within the Boyle Heights Community Plan Area as provided below:



Proposed Transit Enhanced Network






Proposed Bicycle Enhanced Network


