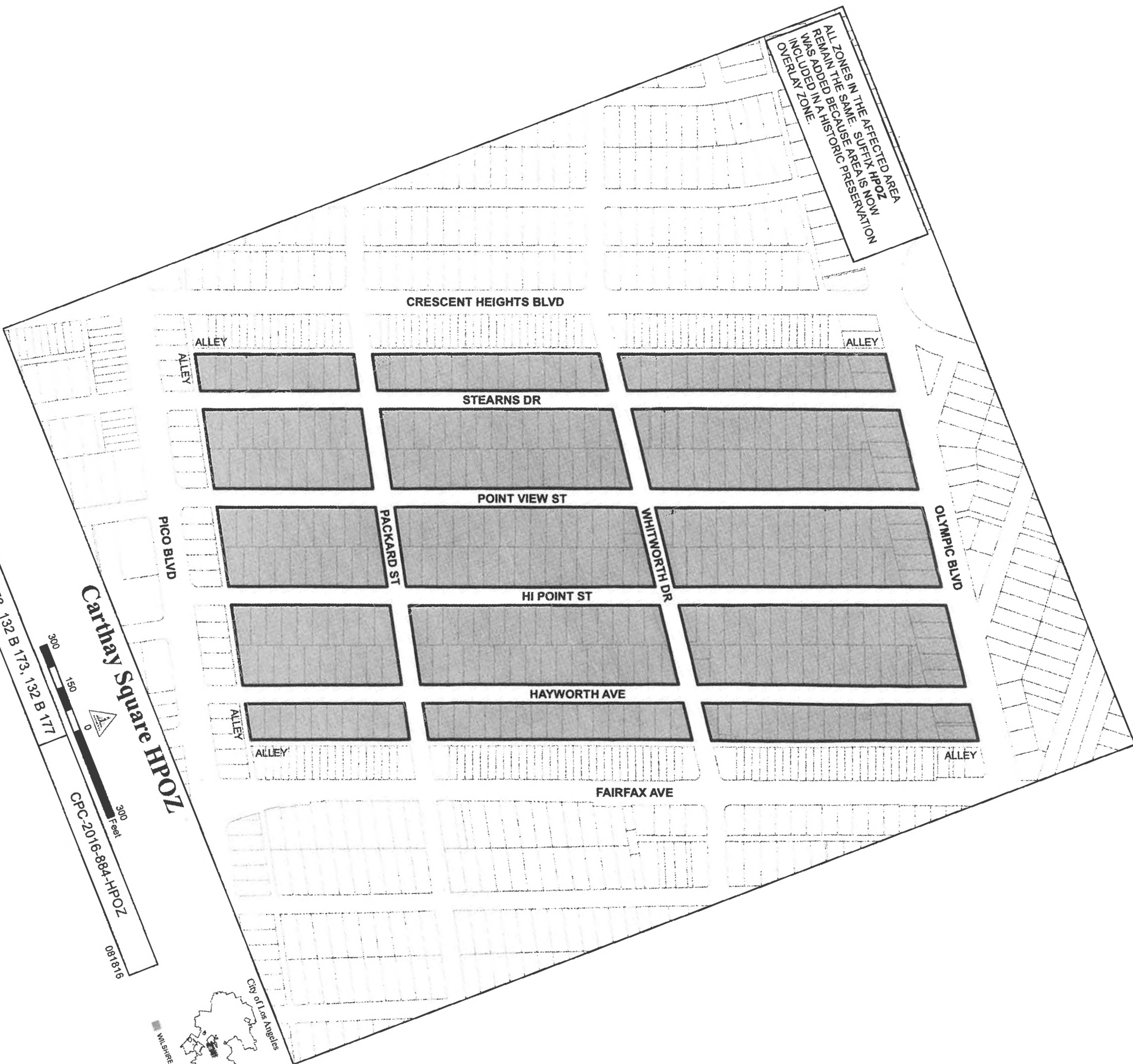
An ordinance establishing the *Carthay Square Historic Preservation Overlay Zone* pursuant to the provisions of Section 12.20.3 of the Los Angeles Municipal Code (the Code) and amending Section 12.04 of the Code by amending the zoning map,

THE PEOPLE OF THE CITY OF LOS ANGELES DO ORDAIN AS FOLLOWS:

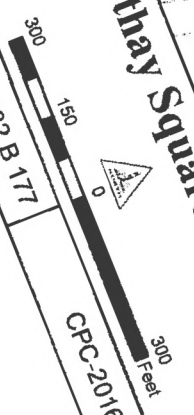
Section 1. Pursuant to Section 12.20.3 of the Los Angeles Municipal Code, the Carthay Square Historic Preservation Overlay Zone is hereby established for the properties located within the shaded borders of the zoning map depicted below.

Section 2. The Zoning Map referenced in Section 12.04 of the Los Angeles Municipal Code is hereby amended by changing the zones for the properties located within the shaded borders of the zoning map depicted below to R1-1-0-HPOZ, R2-1-0-HPOZ, [Q]R3-1-0-HPOZ.

ALL ZONES IN THE AFFECTED AREA
REMAIN THE SAME. SUFFIX HPOZ
WAS ADDED BECAUSE AREA IS NOW
INCLUDED IN A HISTORIC PRESERVATION
OVERLAY ZONE.



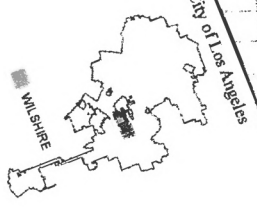
Carthay Square HPOZ

DECLARATION OF POSTING ORDINANCE
