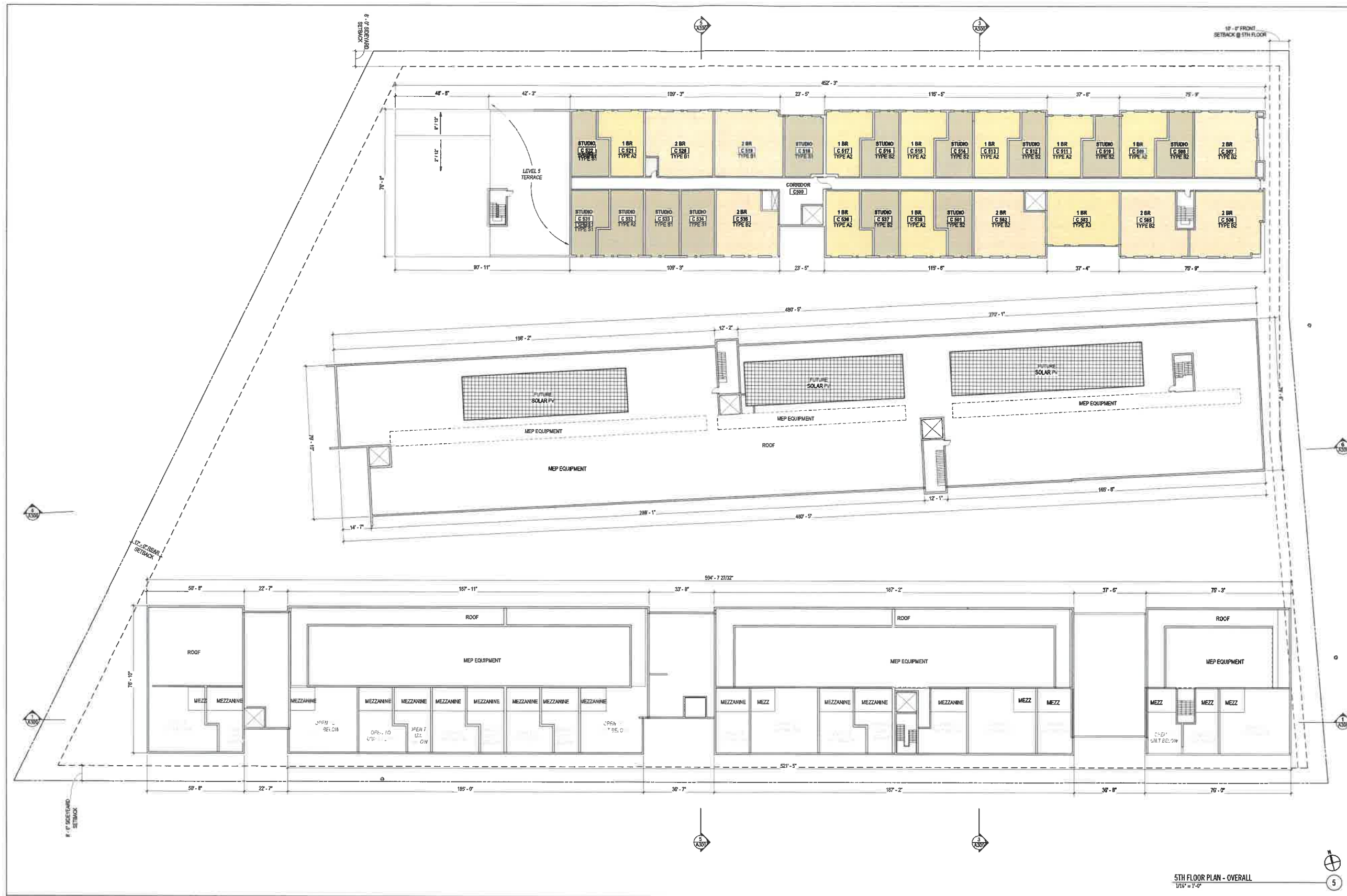

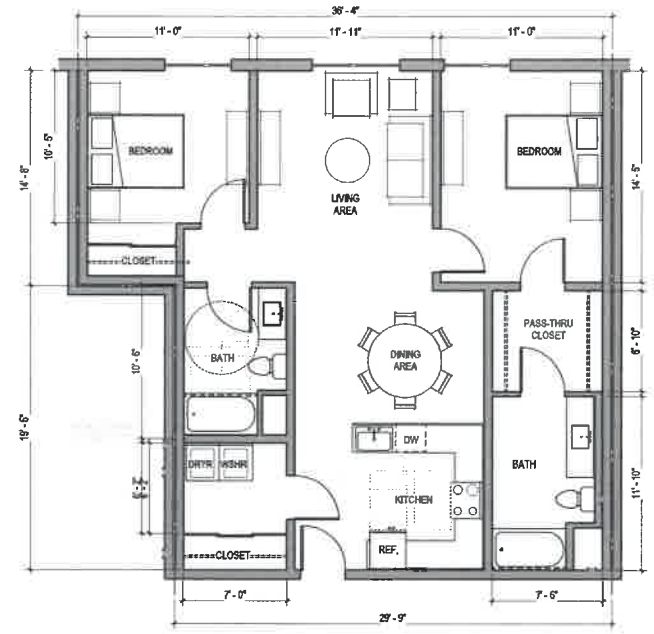

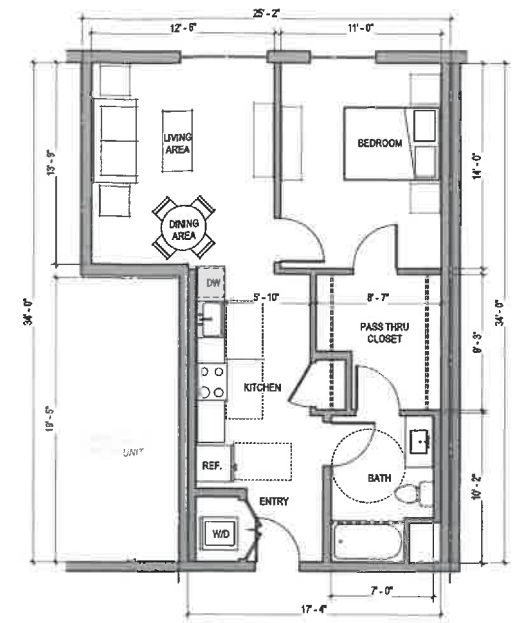

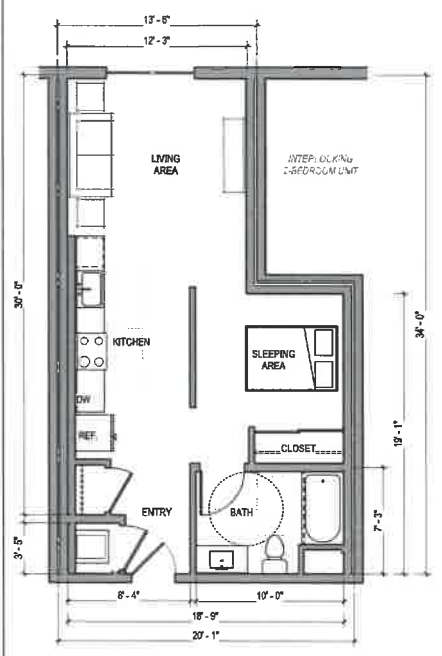
2-BEDROOM UNIT - F

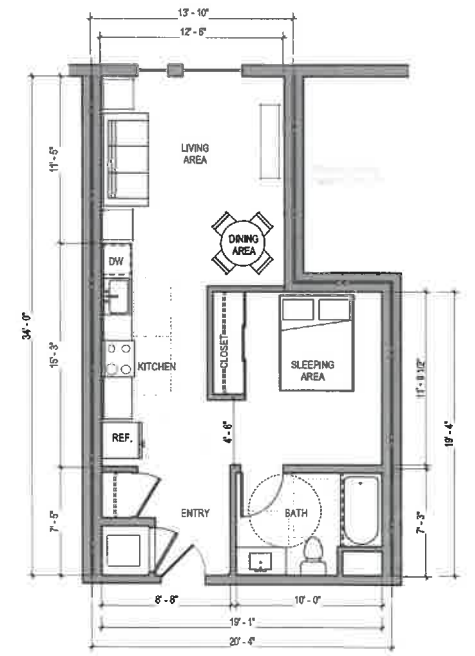
1-BEDROOM UNIT - B

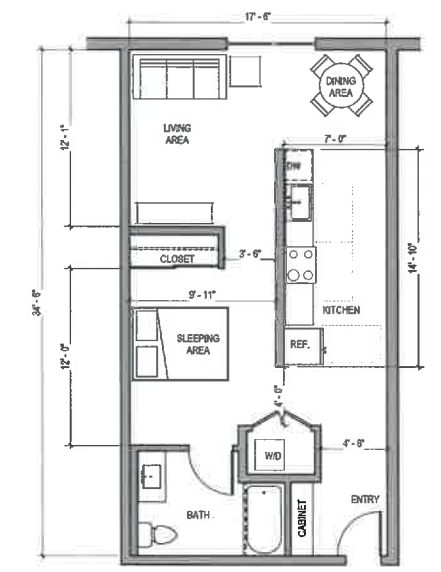
