There has been no activity on this application since June 6, 2021, when a letter was issued stating that the application did not qualify for a Class 3 Categorical Exemption and an Initial Study should be prepared to address the project impacts to the abutting Salkin House (HCM No.1111) in categories of noise with an emphasis on groundborne vibrations, cultural resources, and geology and soils. Subsequently, staff followed up with the applicant on April 10, 2023 and July 6, 2023. However, no action has been taken to provide the requested information.
